The purpose of this modification is to establish a smooth and orderly transition to a new contractor pursuant to FAR 52.237-3 "Continuity of Services" and to correct inadequacies in a PSI reflood model developed under modification No. 7 pursuant to FAR 52.246-5 "Inspection of Services - Cost Reimbursement". In addition, the contract period of performance will be extended to April 30, 1997 and the contract estimated cost will be raised to allow for these transitional activities. Accordingly, the contract is hereby modified as follows:

1. The following language is hereby incorporated into the contract as Section C.1.3.2.A.5:

Contract Sections C.1.3.2.A.5

(1) The Contractor shall close out existing trouble reports.

Completion Date: February 1, 1997

(2) The Contractor shall complete remaining quality assurance activities.

Completion Date: March 1, 1997

(3) The Contractor shall assist the new contractor in making the transition.

(a) The following items have already been delivered to the new contractor:

1. TRACB Version 0.4 (CAMP version).
2. Code documentation including NUREG/CR-4356; vols. 1 and 2, NUREG/CR-3633 vol. 3, NUREG/CR-4391, and the TRAC-BF1 MANUAL: EXTENSIONS TO TRAC-BD1/MOD1.
3. List of approved Users and updates.

(b) The Contractor shall transfer the following items to the new contractor:

1. TRACB Version 0.3 including all backup tapes leading up to these versions as well as Version 0.4.
2. Applicable input decks.
3. Quality Assurance materials.
4. Assessment materials and reports.
5. All material obtained from INEL in the initial transition.
6. All work performed for the NRC on the SBWR.

(4) Pursuant to Modification No. 7 of the existing contract, a previous version of a PSI reflood model has been implemented and assessed but was found to be inadequate. To correct the inadequacies, the Contractor shall complete, implement, document, and assess an improved PSI reflood model that has been recently developed by PSI. The deliverables are to be an implemented, documented, and assessed PSI reflood model.

Estimated Effort: 1 Staff-months
Estimated Completion Date: April 30, 1997

2. Section F.6 "Duration of Contract" is hereby revised to read as follows:

"The contract shall commence on August 3, 1992 and will expire on April 30, 1997."

3. The contract estimated cost is hereby increased by \$83,529 from \$786,907 to \$870,436. \$83,529 in FY 97 funding is hereby allotted to this contract in support of the above described effort. As a result, Section B.3 is hereby deleted in its entirety and replaced by the following Section B.3 Consideration and Obligation - Cost Reimbursement (JUN 1988):

B.3 CONSIDERATION AND OBLIGATION - COST REIMBURSEMENT (JUN 1988)

a. The total estimated cost to the Government for full performance of this contract is \$870,436.

b. The amount currently obligated by the Government with respect to this contract is \$870,436.

4. FAR Clause 52.237-3 "Continuity of Services (JAN 1991)" is hereby incorporated into this contract by reference at Section 1.1 of the contract.

5. A summary of obligations for this contract from award date through the date of this action is given below:
