Gentlemen:

By letter dated July 10, 1985, (J. Ted Enos to John T. Collins), Subject: Arkansas Nuclear One Units 1 and 2, Docket Nos. 50-313 and 50-368, License Nos. DPR-51 and NPF-6, Quality Assurance Manual - Operations, Revision 7, Arkansas Power and Light transmitted to Region IV two copies of the subject manual "per the requirement of 10 CFR 50.17(e)(i)."

Region IV notes that you do not identify the subject manual as your topical report, nor as your submittal for acceptance in accordance with 10 CFR 50.54(a).

Though not so specified in your letter, Region IV presumes that your transmittal is considered by you to be a submittal of a revision to your previously accepted quality assurance program description (Topical Report) without a reduction in commitment, as specified in 10 CFR 50.54(a)(3).
