Dear Ms. Jones:

This is in partial response to your letter dated February 13, 1985, in which you requested, pursuant to the Freedom of Information Act (FOIA), copies of any and all records relating to (a) any actions taken under 10 CFR Part 55 (§55.40(b)) to revoke, suspend or modify the license of any operator or senior operator; and/or (b) enforcement actions, under 10 CFR Part 2, taken against individual licensed nuclear power plant operators or senior operators. You stated your willingness to accept records containing deletions of any identification of any individual against whom any such action has been taken.


Copies of the records listed on the enclosed Appendix A are being placed in the NRC's Public Document Room (PDR), 1717 H Street, NW, Washington, DC 20555, where they will be available for public inspection and copying. We have deleted from the released records the identification of any individual against whom any action has been taken. You may obtain access to these records by presenting a copy of this letter to the PDR staff or by requesting PDR folder FOIA-85-106 under your name. There is no charge for inspecting records maintained in the PDR. We are enclosing a copy of a notice that provides charges and procedures for obtaining copies of records from the PDR.

In view of the very large number of records similar to those identified on Appendix A which NRC staff would be required to search to identify the records subject to your request, Mr. Karas telephoned you for clarification of the scope of your request. He suggested that you telephone Mr. Don H. Beckham, Chief, Operator Licensing Branch, Office of Nuclear Reactor Regulations ((301) 492-4868) to obtain information which would be generally responsive to your request and requirements. In the meantime, as agreed, we have suspended our processing of your request.
