On August 28, 1985, Commonwealth Edison Company filed its sixth partial response to Intervenor Rorem, et al. ("Intervenors") First Set of Quality Assurance Interrogatories and Request to Produce. The sixth partial response provided responses to Specific Interrogatories 58 and 59, which pose specific questions with respect to the 68 separate items of Intervenor QA Contention. Enclosed herewith are the affidavits of Messrs. Gieseke, Seltmann and Hoffer supporting certain of those responses. In addition, certain of the responses have been revised or corrected as noted on the face of each affidavit.

The affidavits of Messrs. 
