Subsequently, an administrative discrepancy was identified in the Appendices file of the referenced UFSAR Revision 24 update. As a result, EGC is submitting an amended Appendices file of Revision 24 LSCS UFSAR to address the discrepancy.

The enclosed amended UFSAR Appendices file is provided in electronic format on Optical Storage Media (OSM) and supersedes the Appendices file submitted on April 13, 2020. The electronic version is being submitted in accordance with 10 CFR 50.4(b)(6).

The April 13, 2020, letter included a brief summary of the changes incorporated into UFSAR Revision 24, a brief summary of the changes incorporated into FPR Revision 9 as well as summary reports pursuant to 10 CFR 50.59, 10 CFR 72.48 and 10 CFR 54.37(b). This amended UFSAR Revision 24 Appendices update does not affect these summary discussions.
