SUBJECT: EMERGENCY PLAN DEFICIENCY - SEQUOYAH NUCLEAR PLANT
DOCKET NOS. 50-327 AND 50-328

We have completed our review of Revision 20 to the Sequoyah Plan dated June 7, 1985.

Our review indicates that this change is inconsistent with planning guidance specified in NUREG-0654, Section II.B.9. Based on our review and discussion with your staff, the reason for this change was to remove offsite agency support agreement with the Chattanooga Fire Department from the Plan and substitute for it a letter of agreement with the Soddy-Daisy Fire Department. However, the controlled copy of the plan submitted to the Regional Office for review did not contain a copy of the Soddy-Daisy agreement as specified in Sections 4.2.2 (page 28) and 7.1.8.1 (page 105) of the Sequoyah Radiological Plan. In a telephone conversation on July 25, 1985, with members of your staff, a request was made for a copy of the Soddy-Daisy agreement. The copy provided to the Region showed an issue date of June 29, 1983. Your commitment in Emergency Plan Implementing Procedure SQN-IPD, MSEC, IP-12 requires biennial updating of such letters of agreement. The copy of the letter of agreement provided this office exceeded the biennial requirement.

This matter was discussed between Mr. W. E. Cline of our staff and Mr. B. Marks of your staff on August 19, 1985. Remedial actions were discussed, and your representative indicated that corrective action would be taken on this matter.

To preclude a violation of regulatory requirements, you must not continue to implement the change deemed inconsistent. Please modify your plan to correct those pages necessary to maintain plan continuity. We request that these corrections be provided to us within 45 days of the date of this letter. With the exception of the noted change, the SQN-REP continues to meet the planning standards and provisions of 10 CFR 50.47(b), 10 CFR 50, Appendix E, and NUREG-0654.
