Gentlemen:

This refers to the special physical security inspection conducted by Mr. G. L. Pirtle of this office on July 12-17, 1985, of activities at the Point Beach Nuclear Plant authorized by NRC Operating Licenses No. DPR-24 and No. DPR-27 and to the discussion of our findings with Mr. J. Zach and other members of your staff at the conclusion of the onsite inspection.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

During this inspection, certain of your activities appeared to be in non-compliance with NRC requirements as described in the Paragraph 3.a. of the report details. However, the violation meets the criteria in 10 CFR Part 2, Appendix C, Section IV.A as a licensee identified violation. Consequently, a Notice of Violation will not be issued and we have no further questions regarding this matter at this time.

Paragraph 3.a. of the Report Details also identifies corrective actions to be taken to resolve two concerns pertaining to the weapon safety/control program. Please advise us in writing within 30 days after receipt of this report if our understanding of your actions is incorrect.

Areas examined during this inspection concern a subject matter which is exempt from disclosure according to Section 73.21(c)(2) of the NRC's "Rules of Practice," Part 73, Title 10, Code of Federal Regulations. This information must be handled and protected in accordance with the provisions of 10 CFR 73.21. Consequently, the enclosure to this letter and our report of this inspection will not be placed in the Public Document Room.
