This letter is in support of a request by Canberra Industries, Inc. (the "Company") the parent company of Packard Instrument Company, Inc. for the NRC's consent to a pending transaction in which 70% of the Company's stock will be acquired by CII Acquisition LLC (the "Acquisition Entity"), a newly formed Delaware limited liability company organized by Stonington Partners, Inc. ("Stonington") on behalf of Stonington Capital Appreciation 1994 Fund, L.P. (the "Fund").

In support of the Company's request, we confirm the foregoing and, as the Company's principal shareholder following the transaction, hereby agree not to interfere with Packard's obligations to continue to abide by the terms of the license.
