All red emergency phones, except the Sheriff's phone, started to ring and were found to be inoperable when answered. Local telephone lines (outside the Charleviox exchange) were also lost. The Plant's radio system and the Sheriff's phone remained in service.

Local authorities were notified of the loss of offsite communications via the Sheriff's phone. Utilizing the Plant radio system notification of this event was given to the Michigan State Police, who in turn notified the State Health Department and Regional Power Control in Grand Rapids who in turn notified the Region III Nuclear Regulatory Commission. An On-call Technical Advisor/-Superintendent was located and given a radio.

After three hours and twenty two minutes offsite communication was returned to service.

Cause

The disruption of the Communication Service was due to a Michigan Bell human error. During a Michigan Bell routine operation, Michigan Bell personnel cut a toll cable disrupting service. The print for the buried cable showed only one cable in the trench, Michigan Bell personnel were unaware that there were two cables in the trench.

No further updates are planned.
