REQUEST UNDER THE FREEDOM OF INFORMATION ACT (FOIA)

TO WHOM IT MAY CONCERN:

The United States Nuclear Regulatory Commission on December 12, 1996 did issue a finding against Public Service Electric and Gas Salem and/or Hope Creek Generating Stations for harassment of whistle-blowers at the Lower Alloways Creek Township Reactor Complex. Specifically, the NRC issued a statement that it issuing a fine to PSE&G for harassment of a Safety Review Engineer who had supported two subordinates who tried to raise a safety concern in December of 1992. We understand the issue involved retaliation against the Engineer by making negative comments in performance appraisal.

Request is made pursuant to the Freedom of Information Act for the following:

•The finding of the NRC of harassment of whistle-blowers at PSE&G

•Copies of the findings of the NRC regarding harassment of engineers at PSE&G

•The determination of the NRC relating in any way to harassment of employees at PSE&G


