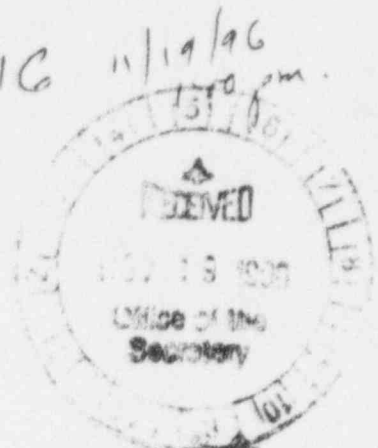

If feasible it may be better
to entomb fuel rods in power reactors
and/or other long lived high level
waste on site rather than transporting
it long distances to a special
site, such as Yucca Mountain,
the possibility of leaking casks
used to transport the waste
needs to be solved as well as
other ^{environmental} problems with the proposed site before
plans are finalized
