Summary Description of Changes

The following list provides a synopsis of the changes incorporated into PGE-1012, Amendment 18. These changes have been evaluated and determined not to involve an unreviewed safety question as required by 10 CFR 50.59.

In accordance with 10 CFR 50.48(f), Amendment 18 reflects revisions to the Fire Protection Program made during decommissioning activities. The changes do not reduce the effectiveness of fire protection for facilities, systems, and equipment which could result in a radiological hazard, and take into account the decommissioning plant conditions and activities.

These changes also have been shown to meet the criteria of Amendment No. 192 of Trojan Possession Only License, NPF-1, in that the changes do not adversely impact the safe storage of irradiated fuel or increase the likelihood of an offsite release of radioactive material due to a fire.

LDCR 97-011 These changes reflect the use of the Condensate Demineralizer Building for radwaste processing. Section 5 was revised to correct the description concerning combustion product monitoring. Exception to the applicable Branch Technical Position was clarified and changes were made to denote that automatic fire detection is not installed or required in the Condensate Demineralizer Building.

LDCR 97-014 Changes to the text were made to delete specific fire protection equipment that has been deactivated and removed. A correction to Section 3.8 was included to reflect a two-person fire brigade, a change that was made with Revision 17.
