2. If an addressee chooses not to take the requested actions, the 45-day response should provide a description of any proposed alternative course of action, the schedule for completing the alternative course of action (if applicable), and the safety basis for determining the acceptability of the planned alternative course of action.

By letter dated August 19, 1996 (Reference b), we informed the Commission of our intention to implement the "Requested Actions," and transmitted a report (Document No. 31-B9604-102) prepared by our Independent Spent Fuel Storage Installation vendor, VECTRA Technologies, Inc., providing the response to the requested Action Items 1(a), 1(b), and 1(c). Please be advised that Baltimore Gas and Electric Company has reviewed Reference (d) and concurs with its contents. This transmittal completes our response concerning Bulletin 96-04, Requested Action Items 1(d) and 2.
