Gentlemen:

This refers to the inspection conducted by Mr. R. T. Dodds and J. D. Woessner of this office on June 23-25, 1975 of activities authorized by NRC License No. DPR-7, and to the discussion of our findings held by Mr. Dodds with Mr. W. A. Raymond and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Based on the results of this inspection, it appears that one of your activities was not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. This item of noncompliance has been categorized into a level as described in our correspondence to you dated December 31, 1974. This notice is sent to you pursuant to the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Section 2.201 requires you to submit to this office, within twenty (20) days of your receipt of this notice, a written statement or explanation in reply including: (1) corrective steps which have been taken by you and the results achieved; (2) corrective steps which will be taken to avoid further violations; and (3) the date when full compliance will be achieved. Your reply should also indicate how you plan to routinely evaluate the performance of the liquid waste system vent monitor to determine possible system degradation as noted in paragraph 4.a.(7) of the enclosed report.
