Please take notice that no request for a formal hearing having been filed following publication of the notice of proposed action in the Federal Register, the Atomic Energy Commission has issued, effective as of the date of issuance, Amendment No. 5 to Facility License No. DPR-7. The license authorizes the Pacific Gas and Electric Company ("the licensee") to operate its nuclear reactor located in Humboldt County, California. The amendment authorizes the licensee to conduct a 15-day test program to demonstrate power operation of the Humboldt Bay Unit No. 3 reactor at power levels up to 230 megawatts (thermal).
