Dear Mr. and Ms. Sweeney:

In response to your January 30, 1974 request, I am enclosing a map which shows power reactors operating, under construction or ordered as of the end of 1973. There are many other research reactors at universities, government-owned facilities, and other locations throughout the country, and the enclosed booklet "Nuclear Reactors Built, Being Built or Planned" should provide the information you wish.

The following information is provided in response to your specific requests:

1. Humboldt Bay - A Provisional Operating License was issued 8-28-62, and a full term license was issued 1-21-69. The full-term license expires 11-9-2000. The plant is presently operating at full power and has been since 1962, except for scheduled shutdowns for maintenance.
2. San Onofre Unit 1 - A Provisional Operating License was issued 3-27-67, and an application is currently under review for a full-term license. The plant is presently operating at full power, having returned to operation 1/22/74, following a scheduled shutdown for maintenance. Construction permits were issued on 10-18-73 for Units 2 and 3 at the San Onofre site.
3. Diablo Canyon - A construction permit was issued for Unit 1 on 4-23-68 and for Unit 2 on 12-9-70. Pacific Gas and Electric Company's application for Operating Licenses was docketed on 10-2-73 and is currently under review by the Regulatory staff with a decision expected in November, 1974.

4. Malibu - An application for Construction Permits for the Malibu plant was received in November, 1963. Following a public hearing in 1965 on the application, the licensing board's decision authorizing construction was reversed by the Commission in 1967 and was remanded to the board for further information. The applicant never supplied the additional information required by the board, and has indicated that the application will be withdrawn. At the present time, we are awaiting a motion from the applicant to formally withdraw the application.
