SUBJECT: OFFSITE RADIOACTIVITY RELEASE

During an unusually heavy spring blizzard, the plant experienced a partial loss of offsite power at 11:33 MST. Due to the loss of offsite power, a manual scram from 24% power was initiated at 11:42 MST. Due to subsequent loss of helium circulators and helium purification system, a noble gas release of approximately 96 millicuries occurred over a period of approximately 1 hour. The release rate was less than 0.1% of the Technical Specification limits. As of 3:30 CST, the plant is in a stable condition, offsite power has been restored and the release has terminated.

The state of Colorado has been informed.

Region IV received notification of this occurrence by the headquarters operations officer at 1:20 p.m. CST.
