Dear Mr. Macek:

This refers to the inspection conducted on May 6, 1997, at the Theda Clark Regional Medical Center in Neenah, Wisconsin. The purpose of the inspection was to review a misadministration event that your staff reported to the NRC on May 1, 1997, involving a patient treatment that occurred on December 20, 1996, and to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the site inspection, the findings were discussed with Messrs. Marlewski, Mushett and Sanders of your staff.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, independent measurements, and interviews with personnel.

Based on the results of this inspection, the NRC has determined that a violation of NRC requirements occurred. This violation is cited in the enclosed Notice of Violation (Notice). A written response is required.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter, the enclosures, and your response to this letter will be placed in the NRC Public Document Room (PDR). To the extent possible, your response should not include any personal privacy, proprietary, or safeguards information so that it can be placed in the PDR without redaction.
