The objective of the inspection effort was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. The enclosed report presents the results of that inspection.

No cited violations of NRC requirements were noted in the areas inspected. The Vehicle Barrier System was effectively implemented. Some procedure weaknesses were noted in reference to the Vehicle Barrier System. Positive observations were noted in several areas inspected including, for example, security force training and security force performance.
