Enclosed is Amendment No. 12 to your NRC Materials License No. 24-32221-01 in accordance with your request. Please note that based on the Sealed Source and Device Registry (SSDR) for the Troxler Electronic Laboratories Model 3400 Series nuclear gauge (Registration No. NC-646-D-130-S), the authorized sealed sources in Items 6.J. and 6.K. of the license were updated. In addition, your license is authorized for a self-shielded irradiator in Item 6.F. and therefore a program code 03510 was added to your license. A description of the program code is posted in the NRC's website at <https://www.nrc.gov/materials/miau/mat-toolkits.html>. Based on this change in the program code for your license, your annual license fee may increase. For your information, the annual NRC materials license fee may change yearly and is reflected in the Title 10 of the *Code of Federal Regulations* (10 CFR) 171(d). Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
