The purpose of this modification is to: (1) Exercise the option to extend the period of performance of the contract from August 14, 1998 through August 13, 1998; and (2) increase the contract ceiling in the contract by \$2,178,878.00, from \$6,264,750.00 to \$8,443,628. Accordingly, the contract is hereby modified to read as follows:

- Section B.3, CONSIDERATION AND OBLIGATION—TASK ORDERS, paragraph a, first sentence, is deleted and substituted with the following in lieu thereof:
  - "(a) The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this contract is \$8,443,628.00."
- Section F, Subsection F.4 entitled, DURATION OF CONTRACT PERIOD is hereby deleted in its entirety and substituted with the following in lieu thereof:

"The ordering period for this contract shall commence on August 14, 1995 and will expire on August 13, 1999. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) The term of this contract may be extended at the option of the Government for an additional year."

NOTE: This modification obligates no FY 97 funds. Funding will be provided on a task ordering basis.

All other terms and conditions of the subject contract remain unchanged.
