Stephen G. Bindon, first being duly sworn, deposes and says that:

1. I am Vice-President and General Manager of Trijicon, Inc., and the designated Radiation Safety Officer. I recently responded to questions concerning the failure rates of Trijicon tritium iron sights for guns and have personal knowledge of the facts and matters stated in this affidavit and could and would so testify if called upon to do so. Trijicon has specifically delegated to me the duties and responsibilities of responding to this inquiry from the Nuclear Regulatory Commission and I have compiled various studies and data.

2. As indicated in my December 3, 1996 correspondence, competitors of Trijicon have experienced difficulty with failure of their sights. The information provided in my letter contains specific information about our sights which is not readily available to the public, especially our competitors.

3. The specific items we believe are protected from disclosure pursuant to 10 CFR 2.790(a)(4) as trade secret and commercial or financial information which should remain confidential are as follows:

a. The last paragraph on the first page, identified with "C.";

b. All of page two; and

c. The drawings attached as exhibits to the letter.

4. The information provided in the identified sections could be used by competitors of Trijicon to alter both their product and their marketing strategy. They would have no other readily available source for this information as it is all internally maintained by Trijicon with limited access by its employees. We have specifically identified the problem areas with our competitors' products and what a proper method, namely ours, would be. In balancing the public's need to have access to information and Trijicon's right to conduct business and protect its trade secrets and information developed by thousands of hours of work, we believe the balance tips very heavily toward maintaining the confidential nature of my December 3, 1996 letter, at least the paragraphs and material identified above.

I declare under the laws of the state of Michigan the foregoing is true
and correct to the best of my ability.
