14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)  
This modification is issued to provide incremental funding in the amount of \$14,239.00. As a result of this action, the contract is now fully funded, and the total amount obligated by the Nuclear Regulatory Commission is increased by \$14,239.00, from \$54,640.00 to \$68,879.00. Accordingly, the contract is hereby modified as follows:

Section B.3, Consideration and Obligation, paragraph b, the first sentence is revised to read:

"The amount presently obligated with respect to this contract is \$68,879.00."  
All other terms and conditions, including the total amount of the contract of \$68,879.00, remain unchanged.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
