Areas examined during the inspection included operational safety verification, maintenance, surveillance, NRC Bulletin followup, followup on previously identified items, and followup on Licensee Event Reports (LERs). Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the NRC inspectors. The inspection findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations were identified.

During this inspection, it was found that certain of your activities appeared to deviate from commitments made to the NRC.
