Your letter dated November 2, 1987 transmitted the results and conclusions of the Regulatory Effectiveness Review (RER) conducted by the NRC's Office of Nuclear Reactor Regulation at Peach Bottom Atomic Power Station, Units 2 and 3, from September 28 through October 2, 1987. The attached enclosure to this letter provides Philadelphia Electric Company's response to the NRC's Final Report of the Peach Bottom Atomic Power Station Regulatory Effectiveness Review. An extension for responding to the Final Report was discussed on December 18, 1987 between R. J. Weindorfer (PECo) and Mr. Robert J. Dube, Division of Reactor Inspection and Safeguards, and was found acceptable.


3. The Response which is sought to be withheld from public disclosure contains details relating to physical security plans for Peach Bottom Atomic Power Station;

4. The information set forth in the Response has been treated as confidential and proprietary information and has been



5. The Response should be considered by the NRC as confidential and proprietary information and be withheld from public disclosure on the grounds that it contains Safeguards Information, it contains details relating to the physical security plans of a licensed facility, it contains detailed information which could be used to compromise the safety and security of the facility, such disclosure is not required in the public interest and such disclosure would adversely affect the interests of Philadelphia Electric Company.
