Re: Turkey Point Units 3 and 4
Docket Nos. 50-250 and 50-251
Response to Notice of Violation
EA 87-179 (Inspection Reports 87-38 and 87-47)

On February 11, 1988, the NRC issued a Notice of Violation and Proposed Imposition of Civil Penalty, EA 87-179 to Florida Power & Light Company (FPL). This notice is based on findings described in NRC Inspection Reports 50-250/87-38; 50-251/87-38; 50-250/87-47 and 50-251/87-47.

FPL's reply to the Notice of Violation is in two parts. Attachment A responds to the cited violations, admitting to them and setting forth the reasons for their occurrence and the specific corrective actions which have been taken or are planned. Attachment B provides additional programmatic corrective actions including enhanced training aimed at raising the awareness of all Turkey Point Nuclear Plant employees to the importance of plant security and their individual responsibilities for assuring its effectiveness. This training will be given to both the contractor security guard force and to general plant employees who hold unescorted access to the plant. Also, FPL supervision of the contractor guard force will be increased to provide round-the-clock supervision of the contractor. This will increase FPL's ability to effectively manage and control security activities and improve program performance.


FPL remains committed to providing a quality security program at Turkey Point. We have initiated proactive assessments intended to identify areas for improvement in security. Our programmatic approach to security enhancements addresses facilities and equipment, personnel performance, plans, procedures and organization. We have implemented projects to provide state of the art systems as well as interim enhancements to improve current operations. We are continuing to work with our security force contractor to identify areas to improve personnel performance. While some results have been seen, this effort will continue to be emphasized until performance levels meet FPL's expectations. We are preparing a complete revision to the Turkey Point physical security plan which will provide for a more user friendly document. FPL's expectations relating to each individual's responsibility for meeting security requirements will continue to be strongly communicated to all plant personnel until lasting results are evident. FPL fully recognizes that security is not the responsibility of just our contractor but of every badged individual.

In view of FPL's findings, a check for the full amount of the civil penalty is enclosed.

In accordance with 10 CFR 2.790(d) and 10 CFR 73.21, the enclosures to the letter are exempt from public disclosure.




