Reference 1 transmitted a proposed amendment to the Kewaunee Nuclear Power Plant (KNPP) Physical Security Plan in response to the Miscellaneous Amendments and Search Requirements (Reference 3). Reference 2 requested additional information regarding implementation of specific parts of the regulation. During discussions with NRC staff, WPSC agreed to address each of the NRC requests identified in Reference 2 and to resubmit all KNPP Industrial Security Manual (ISM) pages affected by this proposed amendment.

Attachment 1 provides a description of the proposed revisions which responds to each of the NRC requests identified in Reference 2. Attachment 2 provides a complete summary of the proposed revisions made in ISM proposed amendment 10a. This summary includes revisions made in this submittal as well as those made in Reference 1. Attachment 3 provides the KNPP Industrial Security Manual page changes associated with this proposed amendment. The proposed revisions are highlighted with change bars.

WPSC proposes that the Industrial Security Manual changes (except for the search requirements) will be implemented within 180 days after Commission approval of the revisions as specified by 10 CFR 73.55. The ISM changes regarding search requirements (section 3.2.1.4) will be implemented within 60 days after Commission approval as specified by 10 CFR 73.55.
