Platina Laboratories requests an amendment to add 10 micrograms of "Any special nuclear material in any chemical or physical form" to the above referenced license. All other uses and conditions will remain the same.

In industry the radionuclide purity of uranium and plutonium compounds is rarely one hundred percent. For example, trace amounts of Pu-240, Pu-241 and Pu-242, may be present in precious metal compounds containing Pu-239 sent to our facility for chemical purification. To allow receipt and use of any materials that contain these trace isotopes Platina Laboratories requests the above amendment.

Platina Laboratories requests special attention be given to this amendment request to allow us to receive materials currently being held by one of our customers.
