To Whom It May Concern:

I represent [redacted] a former employee of Daniel International, a civil inspector for Daniel during the construction of the Wolf Creek Generating Station in Central Kansas, near Waverly and Burlingame, Kansas, in 1983-1984.

[redacted] reported to you and to the owners' Quality First program certain deficiencies in construction and procedure at Wolf Creek. You conducted an investigation of those reported concerns sometime in the spring and summer of 1984.

Pursuant to the Freedom of Information Act (FOIA, 5 U.S.C. 552), I am requesting copies of any and all NRC records and information, including but not limited to notes, letters, memoranda, drafts, minutes, diaries, logs, calendars, tapes, transcripts, summaries, interview reports, procedures, instructions, engineering analysis, drawings, files, graphs, charts, maps, photographs, agreements, handwritten notes, studies, data sheets, notebooks, books, telephone messages, computations, interim and/or final reports, status reports, and any and all other records relevant to and/or generated in connection with your investigation of said deficiencies in construction and procedure at Wolf Creek.

This includes, but is not limited to all of your investigatory documents, formal or informal hearings, and the name of the person in your department who is most familiar with this investigation.

We request that fees be waived, because "finding the information can be considered as primarily benefitting the general public." 5 U.S.C. 552 (a)(4)(a). The materials requested are relevant to lawsuits against Daniel for wrongful discharge in retaliation for supplying information to you; a basis for the lawsuit is essentially the violation of public policy.
