

The subject of the intrusion of the GCNP on operations of the Lehigh plant at Cementon has been extensively discussed and the Lehigh Board is convinced that the disruptions caused by the construction of the GCNP at Cementon will be such that they significantly impact the Lehigh production facility and will probably cause its premature closing. Moreover, the construction of the GCNP on Lehigh property at Cementon will deprive Lehigh of its site for a new low cost production facility which will be necessary in the foreseeable future.
