Re: Turkey Point Units 3 and 4 Docket Nos. 50-250 and 50-251 Revised Response to Notice of Violation EA 87-179 (Inspection Reports 87-38 and 87-47)

Florida Power & Light Company (FPL) letter L-88-120, dated March 14, 1988 issued our response to the notice of violation and proposed civil penalty EA 87-179. It later came to our attention that this response contained several inaccurate statements. The NRC Region II Staff and the Turkey Point Senior Resident Inspector were contacted on March 24, 1988 to discuss these items and the proximate cause of the oversight. We are chagrined at the necessity of correcting this response and are resolved to determine and correct the causes that allowed these minor errors to persist throughout our preparation and review process.

Attached is our revised response. Enclosure 1 contains a summary of each revision and a brief description of the evaluation being performed of the original document preparation process. Enclosure 2 is a reissue of Attachment A of our original response with revision bars denoting the changes. Original Attachment 3 remains unchanged.
