SUBJECT: REQUALIFICATION EXAMINATION REPORT, FORT CALHOUN STATION (FCS)

During the week of March 7, 1988, NRC administered examinations to employees currently licensed to operate your FCS facility. These examinations were administered utilizing trial guidelines for requalification examinations entitled, "REQUIREMENTS AND PROCEDURES FOR REQUALIFICATION EXAMINATIONS." Only written and walk-through examinations were administered at this time. The simulator examinations are currently scheduled to be administered in May at the Combustion Engineering Simulator Facility in Windsor Locks, Connecticut. The examination results and preliminary findings were discussed with those members of your staff identified in the enclosed report. The FCS requalification training program will not be reevaluated until simulator examinations are completed. Therefore, at this time the FCS requalification training program remains unsatisfactory for the purpose of certifying the proficiency of a two-year licensee to receive license renewal.

An addendum to this report will be issued after the simulator examinations are completed.
