Enclosed are two copies of WCAP-14776, Revision 2, "WCOBRA/TRAC OSU Long-Term Cooling Final Validation Report," dated May, 1997, which documents the performance of the WCOBRA/TRAC computer code in predicting the long-term cooling (LTC) thermal-hydraulic behavior observed in the OSU integral systems test facility. This material formed the basis for the Westinghouse presentation to the ACRS in March, 1997.


