

By letter dated April 24, 1997 (Reference 1) Union Electric requested an amendment to Facility Operating License NPF-30 for Callaway Plant that provides revisions to reflect necessary changes due to Donald F. Schnell's retirement and his replacement by Garry L. Randolph. As part of the amendment, parts of the Technical Specifications, Section 6.0, are revised to show that the title Senior Vice-President, Nuclear is replaced by the title, Vice-President and Chief Nuclear Officer.

Attachment 2 to Reference 1 provided a Significant Hazards Evaluation. The evaluation concluded that the proposed changes meet the requirements of 10 CFR 50.92(c) and do not involve a significant hazards consideration. This conclusion is based largely on the fact that the overall reporting of management positions remains the same within the Union Electric management structure and that there is no reduction in the level of management oversight in the operation of Callaway Plant.

As further discussed in Reference 2, Mr. Schnell's retirement and replacement involved an organization change that minimizes impact on the Union Electric management structure and ensures no reductions in the level of management oversight in the operation of Callaway Plant. This is supported by the fact that all of the managers who reported to Mr. Randolph continue to do so.

The Manager Quality Assurance, the Manager Nuclear Engineering, the Manager Licensing and Fuels, and the Manager Nuclear Services, however, continue to report to the senior executive in the Nuclear Function. Previously these managers reported to Mr. Schnell as Senior Vice-President, Nuclear, who in turn reported to the President and Chief Executive Officer of Union Electric. Now they report to Mr. Randolph, the Vice President and Chief Nuclear Officer, who in turn reports to the President and Chief Executive Officer of Union Electric.

Because these managers continue to report under the same overall management scheme and philosophy, the original conclusion of the Significant Hazards Evaluation remains valid. However, on page 2 of the Significant Hazards Evaluation (Attachment 2 to Reference 1), the paragraphs under items 1 and 2 make reference to "....the chain of authority and reporting.....remains unchanged". Because, in fact, the chain of authority is altered (VP Operations eliminated), these paragraphs are revised to state that "Within the Union Electric organizational structure, the departments reporting to the former Senior Vice-President, Nuclear now report to the Vice-President and Chief Nuclear Officer. The position of Vice-President and Chief Nuclear Officer now reports to the President & Chief Executive Officer of Union Electric, which is the same management level of reporting as the previous title, Senior Vice-President, Nuclear."

Finally, a correction is required in respect to Reference 2. On page 2 of the letter, at the end of the first paragraph, there is an incorrect reference to the Vice President and Chief Nuclear Officer who reports to the President & Chief Nuclear Officer of Union Electric. The corrected reference is to the Vice President and Chief <u>Nuclear</u> Officer who reports to the President & Chief <u>Executive</u> Officer of Union Electric.

In summary the amendment request and supporting evaluations address the areas of the Technical Specifications which are being revised. Hopefully, this additional information will be helpful in processing the amendment request. Please contact us with any further questions.


