In accordance with your January 29, 1987 telephone conversation with the Licensing staff and your February 3, 1987 letter, your November 12, 1986 request for an amendment to License 37-11438-02 is being processed as an amendment to License 37-11438-01.

A fee of \$120 was paid for the November 12, 1986 application as specified in fee Category 7C of §170.31 of the enclosed 10 CFR 170 for License 37-11438-02.
