DEMAND FOR INFORMATION SUBJECT:

Dear Mr. Torres:

The enclosed Demand for Information (Demand) is being issued to enable the NRC to fully understand the facts and circumstances surrounding the strontium-90 source verification services that you provided to Dr. Luis A. Vázquez in September 1990 and to obtain a clear understanding of the conflicting information provided between your September 15, 1990 letter to Dr. Vázquez and your April 2, 1996 letter to the Nuclear Regulatory Commission. As set forth in the Demand, you may respond to this Demand by filing a written answer, under oath or affirmation, or by setting forth your reasons why this Demand should not have been issued and, if the requested information is not being provided, the reasons why it is not being provided.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," records or documents compiled for enforcement purposes are placed in the NRC Public Document Room (PDR). A copy of this letter, with your address removed, and your response, will be placed in the PDR after 45 days unless you provide sufficient basis to withdraw this letter. To the extent possible, your response should not include any personal privacy or proprietary information so that it can be placed in the PDR without redaction. If personal privacy or proprietary information is necessary to provide an acceptable response, then please provide a bracketed copy of your response that identifies the information that should be protected and a redacted copy of your response that deletes such information. If you request withholding of such material, you must specifically identify the portions of your response that you seek to have withheld and provide in detail the bases for your claim of withholding (e.g., explain why the disclosure of information will create an unwarranted invasion of personal privacy or provide the information required by 10 CFR 2.790(b) to support a request for withholding confidential commercial or financial information).
