Subject: EQUIPMENT QUALIFICATION (EQ) INSPECTION OF LIMERICK GENERATING  
STATION, UNIT 1 (INSPECTION NO. 50-352/88-02)

This letter confirms the dates of February 8 -12, 1988 for the NRC equipment qualification (EQ) inspection of Limerick Generating Station. These dates were established during a previous telephone conversation between your Mr. D. J. Thompson and Mr. Leonard Cheung of this office on January 8, 1988. The inspection will take place at your corporate office and at the plant site.

A management entrance meeting is scheduled for 9:00 a.m. on February 8, 1988 with a management exit meeting tentatively scheduled for 2:30 p.m. on February 12, 1988 at the corporate office. A plant walkdown inspection of specific EQ equipment is planned for Wednesday, February 10, 1988.

The inspection will include the following:

1. Review of your implementation of 10 CFR 50.49 EQ program, including preservation of qualified status of equipment.
2. Review of your implementation of Safety Evaluation Report EQ corrective action commitments.
3. Review of EQ documentation files.
4. Physical inspection of equipment from the EQ Master List.

At least two weeks prior to the inspection we will require one copy of each document identified in attachment 1 with a plus (+) mark.
