Gentlemen:

This refers to the inspection conducted by Messrs. P. H. Harrell and T. Reis of this office during the period December 1-31, 1987, of activities authorized by NRC Operating License DPR-40 for the Fort Calhoun Station, and to the discussion of our findings with you and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included followup on previously identified items, licensee event report followup, operational safety verification, plant tours, safety-related system walkdowns, monthly maintenance observations, monthly surveillance observations, security observations, radiological protection observations, in-office review of periodic and special reports, followup on an onsite event, cold weather preparations, and review of the licensee's program for natural circulation cooldown. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the NRC inspectors. The inspection findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified. Two unresolved items are identified in paragraphs 4.c and 13 of the enclosed inspection report.

We have also examined actions you have taken with regard to previously identified inspection findings. The status of these items is identified in paragraph 2 of the enclosed report.

Should you have any questions concerning this inspection, we will be pleased to discuss them with you.
