SUBJECT: Luminous Devices Containing Tritium at 1200 Commerce Avenue, Union, New Jersey

Dear Mr. Garelick:

This refers to your two letters, both dated June 5, 1997, requesting information regarding the use of luminous "EXIT" signs at 1200 Commerce Avenue, Union, New Jersey. Since both letters request similar information, we are providing a single response to you. We understand from the letters that you are representing an individual who is not a NRC licensee but who recently handled "EXIT" signs which contained tritium.

Self-luminous devices such as "EXIT" signs may be possessed under the conditions of a general license from the NRC or an Agreement State. The NRC regulations for possession of generally-licensed devices are found in Title 10, Code of Federal Regulations, Part 31 (10 CFR 31), "General Domestic Licenses for Byproduct Material". The specific regulations pertaining to self-luminous "EXIT" signs are found in 10 CFR 31.5 "Certain measuring, gauging, or controlling devices". A copy of 10 CFR Part 31 is enclosed for your information. These regulations include the requirements for maintenance, transfer, and disposal of the signs. At the time of purchase, the manufacturer of the signs is required to provide a copy of these regulations to the purchaser.

The manufacture and distribution of these generally-licensed devices requires authorization by a specific license from the NRC or an Agreement State. The NRC regulations pertaining to the manufacture and distribution of "EXIT" signs are found in 10 CFR 32.51 and 32.52. A copy of 10 CFR Part 32 is enclosed for your information. The manufacturer is required to provide to the NRC and to Agreement States a record of all customers to whom the devices were distributed each calendar guarter.

NRC records indicate that three devices were distributed in 1983 to Abex Corporation at 1200 Commerce Avenue, Union, New Jersey by the manufacturer Self-Powered Lighting. NRC records do not show the presence of other devices at that address. Abex Corporation is apparently no longer in business, but representatives of a successor company, Pneumo-Abex, may be contacted at:

In that case, the request must be submitted to the "Director, Division of Freedom of Information and Publications Services, Office of Administration, U.S. Nuclear Regulatory Commission, Washington, DC, 20655" The request must be in writing and clearly state on the envelope that it is a "Freedom of Information Act request". Each record you request must be described in sufficient detail to enable us to identify and find the record.
