In a letter dated May 28, 1997, the U.S. Nuclear Regulatory Commission (NRC) granted its conditional approval of Parsons Power Group, Inc. (Parsons) as the contractor for the conduct of the Independent Corrective Action Verification Program at Millstone Unit No. 2. The NRC's approval was conditioned upon the submittal of certifications of financial independence by corporate officials of both Parsons and Northeast Nuclear Energy Company (NNECO).

NNECO hereby submits the attached Certification of Financial Independence, dated June 16, 1997, that has been executed by its duly authorized representative. As with our previous submittals related to Sargent and Lundy, LLC² and Little Harbor Consultants, Inc.³, we have modified our certification from the form suggested in the NRC's letter to reflect NNECO's Vice President and Treasurer as the signatory, in lieu of NNECO's President and Chief Executive Officer, and to expressly include NNECO's parent and subsidiaries within its scope. Additionally, we have reflected in our certification the corporate structure and ownership of Parsons, as a privately held subsidiary of Parsons Corporation.⁴
