Dear Mr. Sanders:

The purpose of this modification is to decrease the level of effort of the subject task order, in accordance with the attached Statement of Work. As a result, the following changes are hereby made: (1) decrease the number of professional hours by 124 from 490 to 366, (2) decrease the number of non-professional hours by 16 from 32 to 16, (3) decrease the task order obligated and ceiling amounts by \$10,869 from \$41,567 to \$30,698, (3) revise the start date of this task order from "February 11, 1997" to "March 1, 1997", and (4) deobligate excess funds in the amount of \$10,869.

In accordance with Section G.5(c) of the subject contract entitled "Task Order Award," this letter definitizes Modification No. 1 to the subject task order.

The second paragraph of the definitization letter of the basic task order is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 42 shall be in effect from March 1, 1997 through July 30, 1997, with a cost ceiling of \$30,698. The amount of \$27,687 represents the total estimated reimbursable costs, the amount of [redacted] represents the fixed fee, and the amount of [redacted] represents the facilities capital cost of money."
