APPLICANT: LOUISIANA POWER AND LIGHT COMPANY

FACILITY: WATERFORD STEAM ELECTRIC STATION, UNIT 3

On October 25, 1978, we met with the applicant to discuss the security plan. We wanted to make sure that the applicant, prior to submitting the security plan, understands what is needed in the plan to fulfill the requirements of 10 CFR Part 73.55.

An attendance list is enclosed.

The staff noted that the security plan must be in operation about three months prior to fuel loading so that the Office of Inspection and Enforcement will have adequate opportunity to make the necessary inspections prior to issuance of an operating license.

In accordance with proposed Part 73.47, protection for all special nuclear material must be in effect for receipt of fuel. Delivery of fuel is presently scheduled for January 1981, corresponding to the applicant's May 1981 fuel load date.

We noted that we will evaluate the plan against the requirements of Part 73.55 and the acceptance criteria in NUREG-0416.

The applicant described the vital areas and access control. He also provided parish and state police agreement letters. The staff pointed out that a typical letter should be included in the security plan; the others should be in the plant procedures.

In response to a question, the staff noted that the applicant should commit to the minimum number of guards by position and response function.

The applicant expects to submit the security plan in January 1979. This is acceptable to us.
