Gentlemen:

Our current license referenced above empowers Instrument Control Service, Inc. to be in possession of, install and relocate sealed sources as well as change sources, effect source repair, do source installations, perform radiation testing for measurement and servicing of various Valmet, AccuRay and Data Measurement Beta Gauges and Profilographs containing Krypton 85 and Promethium 147.

We are requesting a review of the requirement for ICS to have a license since we do not store, install, relocate nor handle any sources. Our service extends only to the gauge assembly itself. ICS performs no actual work on the sealed sources nor do we handle them in any way. The extent of our current service is to ensure all source shutters are operational.

Any source servicing, change-out, relocation or reinstallation is left to the gauge manufacturers to accomplish. ICS' sole mission is to repair and maintain the electronic systems which the various gauges's supply signals to as a means of production control.

Our personnel do wear safety badges due to work done in proximity to these sealed sources, i.e. on scanner assemblies and drive trains, etc.


