**SUBJECT: NOTICE OF VIOLATION - 030-30931/94-001**

This refers to a telephone discussion between Mr. Herb Kaplan and yourself in May, 1994. The subject of the discussion was your about to expire license and your need to submit a renewal license application to the NRC in accordance with Section 30.3 of Title 10, Code of Federal Regulations, Part 30. During this telephone discussion, we understand you promised to submit a renewal before your June 30, 1994 expiration date. From this discussion, we learned that you still possess material which requires a specific NRC license.

Your possession of that material without a valid, specific license is a violation of Section 30.3 of 10 CFR Part 30. 10 CFR 30.3 requires that except for persons exempted, no person shall possess or use byproduct material except as authorized by a specific or general license. Your previous specific license expired on June 30, 1994 and you have possessed material for which possession requires a specific license.

Also, you must immediately place your radioactive material in secure storage until such time as you acquire a valid license. No other use of the material or purchase of additional material is authorized. Please include a statement in your reply to this Notice of Violation confirming that you have taken this action and describing the controls that will be exercised over the stored material until such time that you obtain a valid license.

Since you plan to continue possession of radioactive material, your corrective steps must include prompt filing of an application for a new license. Accordingly, you must determine if your program is subject to a license fee as required by Section 170.31 of 10 CFR Part 170 and, if one is required, submit the appropriate fee along with the application.

As indicated above, it appears that your activities are not being conducted in full compliance with NRC requirements. A Notice of Violation is enclosed as Appendix A and categorizes the violation by severity level in accordance with the "General Statement of Policy and
