This is to confirm verbal authorization provided to Shirley Afable of your company, on June 9, 1997, to commonce with the work described in the attached SOW.

The purpose of this modification is to add new work in accordance with the attached SOW; increase the task order ceiling amount by \$73,973.00, from \$136,152.00 to \$210,125.00; increase the amount funded in the task order by \$73,973.00, from \$136,152.00 to \$210,125.00; and extend the period of performance from July 1, 1997 to August 31, 1997. Accordingly, the task order is hereby modified:

Second paragraph of the basic task order, beginning with "Task Order No. 216 . . " is deleted and replaced with the following:

"Task Order No. 216 shall be effective March 17, 1997 through August 31, 1997. The total cost ceiling is \$210,125.00, of which the amount of \$201,872.00 represents the reimbursable costs and the amount of \$8,253.00 represent the fixed fee."
