Subject: VIRGIL C. SUMMER NUCLEAR STATION DOCKET NO. 50/395 OPERATING LICENSE NO. NPF-12 REVISION TO TSP 930019 -CHARGING PUMP RUNOUT FLOW LIMIT

On March 11, 1994, South Carolina Electric & Gas Company (SCE&G) submitted a Technical Specification Change Request (TSCR) for Section 4.5.2.h.1. This TSCR proposed an increase in the charging pump runout flow limit from 680 gpm to 700 gpm based on pump testing performed in the Spring of 1993. The change allows an increase in the system's operating margin by providing a greater difference between minimum and maximum flow limits.

On September 1, 1994, a telecon was held with the NRC (Mr. George Wunder and Mr. Frank Orr) to discuss the charging pump test results. The NRC stated that they could not support the increase in pump runout to 700 gpm since pump "C" was not tested to that value. The NRC indicated willingness to accept a TSCR for up to 688 gpm. SCE&G agreed to resubmit the TSCR page reflecting a pump punout limit of 688 gpm. The NRC stated that once "C" pump is tested to 700 cpm, SCE&G can request the higher runout limit. SCE&G also noted that the Small & eak Loss of Coolant Accident analysis results submitted on March 11, 1994, are not affected by a change in pump runout to 688 gpm. In addition, this revision does not affect the safety evaluation and no significant hazards determination previously submitted for this TSCR.

Accordingly, SCE&G submits the attached, revised Technical Specification page 3/4 5-6 which reflects a change to the charging pump runout limit to 688 gpm.
