
Dear Mr. Quay:

Reference 1 provided Revision 3 of the AP600 Emergency Response Guidelines (ERG) for NRC review. Reference 2 provided additional NRC review comments on Revision 2, the resolution of which form the basis for Revision 4 of the ERGs, enclosed for NRC review. Reference 3 provides the responses to Reference 2 RAIs, noting that some resolutions are reflected in Revision 4 of the ERGs.

This submittal completes the Westinghouse response to Reference 2 such that the Westinghouse status for Open Item Tracking System (OITS) item 5519 is now "Closed". The NRC should review the enclosed ERG and Background Information changes and provide Westinghouse with NRC status information; Westinghouse believes this status should be "Resolved".
