ACTION: Final rule: Corrections.

SUMMARY: Several erroneous cross references have been noted in 10 CFR Parts 30, 40, 70, and 72. This final rule corrects the cross reference errors found in §§ 30.36, 40.42, 70.38, and 72.54, which are all titled "Expiration and termination of licenses and decommissioning of sites and separate buildings or outdoor areas."

SUPPLEMENTARY INFORMATION:

As a result of several recent changes to the NRC's regulations affecting decommissioning, the following cross reference errors were noted in 10 CFR parts 30, 40, 70, and 72:

- (1) In 10 CFR 30.36(d) and (g)(3), the cross references to paragraph "(f)(1)" are corrected to read "(g)(1)."
- (2) In 10 CFR 30.36(g)(3)(vi) and (h)(1) and (2), the cross references to paragraph "(h)" are corrected to read "(i)."
- (3) In 10 CFR 40.42(d) and (g)(3), the cross references to paragraph "(f)(1)" are corrected to read "(g)(1)."
- (4) In 10 CFR 40.42(g)(4)(vi) and (h)(1) and (2), the cross references to paragraph "(h)" are corrected to read "(i)."
- (5) In 10 CFR 70.38(d) and (g)(3), the cross references to paragraph "(f)(1)" are corrected to read "(g)(1)."
- (6) In 10 CFR 70.38(g)(4)(vii) and (h)(1) and (2), the cross references to "(h)" are corrected to read "(i)."
- (7) In 10 CFR 72.54(j)(1) and (2), the cross references to "(j)" are corrected to read "(k)."

Because the changes are minor corrective amendments, the NRC has determined that good cause exists to dispense with the notice and comment provisions of the Administrative Procedure Act (APA) pursuant to 5 U.S.C. 553(b)(B). For the same reasons, the NRC has determined that good cause exists to waive the 30-day deferred effective date provisions of the APA (5 U.S.C. 553(d)).

Environmental Impact: Categorical Exclusion

The NRC has determined that this rule is the type of action described as a categorical exclusion in 10 CFR 51.22(c)(2). Therefore, neither an environmental impact statement nor an environmental assessment has been prepared for this final rule.

Paperwork Reduction Act Statement

This final rule does not contain a new or amended information collection requirement subject to the Paperwork Reduction Act (44 U.S.C. 3501 et seq.). Existing requirements were approved by the Office of Management and Budget, approval numbers 3150-0009, 3150-0017, 3150-0020, and 3150-0132.

Regulatory Analysis

A regulatory analysis has not been prepared for this rule because it is administrative in that it corrects erroneous cross references in existing regulations and does not result in any substantive change.

Backfit Analysis

The NRC has determined that the backfit rule, 10 CFR 50.109, does not apply to this final rule and, therefore, that a backfit analysis is not required for this rulemaking because these amendments do not involve any provision that would impose backfits as defined in 10 CFR 50.109(a)(1).

Approved for Publication

The Commission delegated to the EDO (10 CFR 1.31(a)(3)) the authority to develop and promulgate rules as defined in the APA (5 U.S.C. 551 (4)) subject to the limitations in NRC Manual Chapter 0103, Organization and Functions, Office of the Executive Director for Operations, paragraphs 0213, 038, 039, and 0310.

The enclosed final rule, "Minor Corrections," would correct erroneous cross references in 10 CFR Parts 30, 40, 70, and 72 that resulted from several recent changes to the NRC's regulations affecting decommissioning.

This final rule does not constitute a significant question of policy, nor does it amend regulations contained in 10 CFR Parts 7, 8, or 9 Subpart C concerning matters of policy. I, therefore, find that this rule is within the scope of my rulemaking authority and am proceeding to issue it.
