## SUMMARY OF PROPOSED CHANGES

Section	Description of Changes
AC 7.1.1/7.1.2	<ol style="list-style-type: none"><li>1) Revision to pages 7.1-7, 7.1-8 and 7.1-9 to eliminate the title of Superintendent of Training and add the title of Nuclear Training Manager.</li><li>2) Plant Operations Review Committee (PORC) revisions to eliminate from membership the positions of Health Physics Supervisor, Results Instrumentation and Controls Supervisors and Shift Supervisor Training.</li><li>3) PORC revision to change the title of Shift Supervisor Administration to Administrative Shift Supervisor.</li><li>4) Clarification added to page 7.1-9 (Item 2) to limit the number of alternate members who may participate "as voting members" in PORC activities.</li><li>5) Addition to page 7.1-9 (Item 3) to allow the designated alternate PORC Chairman to convene PORC meetings.</li><li>6) Revision to page 7.1-10 (Item a) to add inadvertently omitted Tech. Spec. Section 7.4(d).</li></ol>

- 1) Nuclear Facility Safety Committee (NFSC) Membership revision to indicate how Consultants are appointed (page 7.1-13).

AC 7.4

- 1) Page 7.4-1. Correction of a reference from Regulatory Guide 1.33 to Safety Guide 33.
- 2) Page 7.4-2 (Item b). Revised to indicate that the PORC, "or a subcommittee thereof" may review procedures. Split the paragraph into two sentences for clarity. Changed the word "Manager" to management.
- 3) Page 7.4-3 (Item 3). Revised to indicate that the PORC, "or a subcommittee thereof" may review temporary changes to procedures. Also, changed Superintendent to management.

- 1) Page 7.5-3 (Item c). Updated to reflect recent USNRC organizational changes, NUREG-0325, February, 1987.
