The U. S. Nuclear Regulatory Commission (Commission) has issued Amendment No. 94 to Facility Operating License No. DPR-25 issued to Commonwealth Edison Company, which revises the Technical Specifications for operation of the Dresden Nuclear Power Station, Unit No. 3, located in Grundy County, Illinois.

The amendment issued revises the Technical Specifications to support: 1) changes specific to Cycle 11 reload fuel and analyses; 2) changes resulting from analyses performed to allow equipment out-of-service; and 3) changes provided for clarification or as administrative changes. The amendment also revises the license to delete a condition requiring a safety evaluation for coastdown operation with abnormal feedwater temperature.

The application for the amendment complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's rules and regulations. The Commission has made appropriate findings as required by the Act and the Commission's rules and regulations in 10 CFR Chapter I, which are set forth in the license amendment.


